

Ryerson University Liability Waiver

This form must be completed for Internships, Clinical Placements and Practicums, Study/Work Abroad Programs, Field Trips, and Student Exchange Programs.

Assumptions of Risks

I understand:

- › Participation in a Ryerson University internship, clinical placement or practicum, study/work abroad program, field trip, and/or student exchange program will be off-campus for an extended period of time. During this period, I understand that I will be in unfamiliar surroundings and may be exposed to risks.
- › I may suffer physical injury, sickness, damage or loss to my property, homesickness, loneliness or death; and possibility of violence, crime, civil unrest, or war during my participation at the internship, clinical placement and practicum, study/work abroad program, field trip, and/or student exchange program.
- › Ryerson University may not be able to ensure my safety at all times from such risks and dangers.

Assumptions of Responsibility and Indemnity

I understand:

- › it is my responsibility to abide by all Ryerson University and host institution policies and host country's laws
- › it is my responsibility to acquire medical, health, life insurance coverage
- › I am solely responsible to protect my person and possessions
- › my activities could jeopardize the safety of local hosts and/or institutions. I will not knowingly participate in any political activity that may endanger either party
- › Ryerson University does not carry any insurance for my benefit
- › Ryerson University will not supervise any of the host institutions academic programs, living arrangements, or extracurricular activities
- › Ryerson University through its appointed officers can require my withdrawal from my participation, for reasons of illness, risks within the host country, or conduct unbecoming a Ryerson University student and that in such circumstances, Ryerson University shall be the sole arbiter in any determination concerning my withdrawal that may not be subject to any appeal or review
- › Ryerson University, through the offices of the Government of Canada, will assist at the instance of health risks, violence, crime, civil unrest, or war in the host country. Ryerson University will not be responsible for my safety or well-being or any consequence of my detention or my inability to leave the host country and return to Canada

I agree:

- › to be accountable in all respects for my own actions and not to ask Ryerson University or its employees to accept the consequences thereof
- › to indemnify and hold harmless Ryerson University regarding any damages it suffers as a result of any claims arising such actions

Ryerson University Liability Waiver

I agree:

- › to hold harmless Ryerson University, its officers, agents, employees and students from any and all liability for any loss, damage, injury or expense that I may suffer
- › to responsibility for any such loss, damage, injury or expense
- › my next of kin may suffer for the following reasons but not limited to, negligence, breach of contract or breach of any statutory or other duty of care
- › Ryerson University is unable and unwilling to accept for any loss, damage, injury or expense suffered, sustained or incurred by me while I am a participant and that my participation is subject to this condition
- › I have been advised by Ryerson University of the risks and dangers related by participating in a pre-departure workshop. At the workshop, I will receive or have received the Ryerson "Ryerson, Set, Go Workbook" outlining these responsibilities
- › to inform myself of the risks of traveling to and residing in my host country by reviewing the Department of Foreign Affairs website: www.voyage.gc.ca
- › this agreement cannot be modified except in writing signed by Ryerson University and that no oral modification or interpretation shall be valid. This agreement shall be effective and binding upon my heirs, next of kin, executors, administrators and assigns
- › to authorize Ryerson University to contact my next of kin about me in my absence. I have fully informed them including but not limited to of possible risks and the content of this agreement
- › to consent Ryerson University, its officers, agents, employees to use and disclose my personal information for the purpose of facilitating any communications considered necessary
- › my signature below is given voluntarily in order to indicate that I understand and accept this agreement

By signing this legal document, you are confirming that you agree to all that has been outlined in this document. Additionally, you are giving up certain legal rights including the right to sue.
